Habitat Tucson also partners with the community to provide critical and minor home repair services, which include roof replacements, mechanical system upgrades, exterior repairs, landscaping and neighborhood clean ups and minor interior modifications. These services support long-term health & safety livability for eligible families. In total, 17 comprehensive home repair projects were completed, which include 7 A Brush with Kindness projects and 2 Neighborhood Improvement projects. In addition, as part of Habitat's global impact partnership, 29 families in Mexico, Bangladesh and Nepal now have access to adequate shelter, potable water and sanitation.

In addition, Homeowner Services supports the Housing Rehabilitation program by providing intake and screening services for families needing home repair services.
