

In 2019, Habitat Tucson began construction on the 450th Habitat Tucson home in Southern Arizona. We partner with neighborhoods, volunteers, corporate sponsors, donors and individuals to support a community-wide effort to eradicate poverty housing in Tucson, Amado, Sahuarita, Green Valley and Marana.

Becoming a Volunteer


Application Process

The process of becoming a Habitat for Humanity Tucson volunteer is simple. We ask all volunteers to attend an orientation. You can sign up for one online at HabitatTucson.org/volunteer and click the Volunteer tab. You will register and sign a waiver of liability. Then you're ready to start volunteering! After orientation you can choose to help at our build sites, the HabiStore, administrative, family partner, or assist with home repair or neighborhood revitalization projects. Some volunteer opportunities include additional training including the HabiStore. The Volunteer Resources team will inform you if a position requires additional training.



To become a family partner, work in the office, or become a committee member, an interview is required.

Volunteer Types



****Please note: All volunteers must be 16 years of age or older to volunteer with Habitat Tucson.**

Individuals/Ongoing – You may volunteer as an individual to participate at Habitat events and work shifts. Individuals are welcomed to work in our offices, HabiStore, construction sites and much, much more!

Groups/One-time – Join the many companies, corporations, schools, faith and community groups who've helped build homes and transform communities. Sponsorship opportunities are also

available. Please note, however, that our group volunteer opportunities fill up very quickly. Please contact Volunteer Resources at volunteer@habitatucson.org if you want to participate with a group.

Court Ordered Community Service – You may also volunteer to complete court-ordered (CO) community service, except for the following circumstances: your restitution hours are ordered for a felony offense, a violent crime including a sexual offense, a crime against a minor, theft or robbery. As a CS volunteer, we ask that you present court documentation and sign a Court Ordered Community Service agreement with us. Volunteer Responsibilities

Volunteer Conduct

Volunteers of Habitat Tucson are typically exemplary models of conduct and behavior. If you participate in all the safety requirements, respect your fellow volunteers and staff and follow simple rules of courtesy, you will truly be an ambassador of good will for Habitat Tucson. Dress Guidelines

Habitat Tucson wants to ensure a safe and professional work environment and has a few dress requirements to ensure safety of our volunteers.

Close-toed shoes are mandatory for construction site volunteers as well as HabiStore volunteers. Steel-toed boots are encouraged but not required. Short-shorts and flip-flops are not proper, safe, or professional attire for the Habitat Tucson workplace. Tank Tops are also not allowed at the HabiStore or Construction sites. Office staff volunteers, homeowner partners and committee members do not need to concern themselves with closed-toed shoes.

Hard hats are mandatory and must be worn while in the construction area. Protective glasses must be worn while operating power tools and at any other time that the site supervisor or crew leader deems necessary. Ear protection should be worn on site when using a power tool for a prolonged period, and at any other time that the site supervisor or crew leader deems necessary. Each volunteer should wear a dust mask when installing insulation or when sanding, and any other time that the site supervisor or crew leader deems necessary. The “safety Handbook for Construction Crew Volunteers” specifies protective clothing that must be worn at construction sites. It also identifies attire that may pose a safety hazard and may not be worn – i.e. open-toed shoes. [Click Here](#) to read more about safety for construction volunteers.



Volunteer Registration

All volunteers, both individuals and groups, are required to register for their shifts and events online on our volunteer portal, “Cervis”. Tracking volunteer hours allows us to provide feedback to financial sponsors, apply for grants and give recognition to our volunteers. It is also a way we can identify areas where need help for a certain event or shift. Volunteer Attendance and Punctuality

When you have scheduled a day to volunteer with us — whether at the HabiStore, the administration office, a home repair project, or the construction site — your attendance and punctuality is important for the beginning of everyone’s shift and day. We thank you in advance for understanding that the Habitat team depends on you and we will rely on your timeliness to your workstation.

We cannot fulfill our mission to serve Southern Arizona without the help of volunteers. Being a volunteer with Habitat allows for flexibility in scheduling your workdays, however, please communicate with the Volunteer Manager or cancel your reservation online if you cannot attend an event for which you are signed up.



Policies

What is the Nature of Volunteering at Habitat?

While volunteering requires commitment on your part as a volunteer, there is no contractual obligation of any kind between you and Habitat Tucson. For construction site and HabiStore volunteers we ask for at least a 6-month commitment with a minimum of 2-4 shifts per month. Other positions may have different commitment needs which can be found in our [Volunteer Job Description Handbook](#).



The nature of all work you contribute is free of charge to Habitat Tucson. Neither you nor Habitat Tucson is bound to continue the relationship if either party chooses, at will, to end the volunteer relationship with or without notice. We value your feedback and if you choose to end your partnership and are willing to, please contact volunteer resources at volunteer@habitattucson.org for a brief survey about your service experience.

Fair Volunteer Practices – Equal Volunteer Opportunity

We are committed to provide an environment free of harassment and unlawful activities of any kind, including that which is sexual, age-related, racial, religious, ethnic or disability-related.

Job Training/Placement Programs

Our mission goes beyond providing safe, affordable housing. Habitat Tucson is also committed to providing volunteer opportunities for individuals in job training/placement programs. To maintain our commitment to these programs, we can service three job training or placement programs at a time. Additionally, volunteers within these programs must be able to adhere to safety requirements and to work independent of a job coach while volunteering.

Confidentiality Policies

As a volunteer you are responsible for protecting Habitat Tucson's information. You may, at one time or another, receive personal and/or confidential information relating to our partner families' financial position, other Habitat for Humanity affiliates, other volunteers, donors or other areas of Habitat Tucson operations. As a volunteer, you are required to ensure that this information remains confidential and is not disclosed. If you have any questions about what is confidential, please contact the Volunteer Resources or staff member with whom you are working.



If you are approached with an inquiry, you are unable to answer, please direct the asking party to an available staff member or have them call 520-326-1217.

If you are approached by the media, please have them contact our Marketing and Media Manager at 520-497-2387.

Privacy Policies

We will not share your personal information including name, address, phone numbers, email and your status with us as a volunteer. If you wish to utilize Habitat Tucson as a reference, please inform us with a written/email request, including the name of the individual or organization to which you will be submitting the reference. Requests may be made to the Volunteer Manager.

Whistle Blower Policies

Habitat for Humanity Tucson, Inc. requires directors, officers, employees, and volunteers to observe high standards of business and personal ethics in the conduct of their duties and responsibilities. As representatives of the affiliate, we must practice honesty and integrity in fulfilling our responsibilities and comply with all applicable laws and regulations. Any behavior by an employee or volunteer that violates high ethical standards should be reported to the Director of Human Resources, the Chief Executive Officer or the Board of Directors President, in that order.

Habitat Tucson will not retaliate against you, if in good faith, you are, as a volunteer, making a protest or registering a complaint against a practice, employee, or another individual or entity with whom Habitat Tucson has a business relationship based on a reasonable belief that the practice is in violation of law or public policy.

Health and Safety

Introduction

Habitat for Humanity Tucson employees and volunteers share the responsibility for establishing and maintaining a safe work environment. Habitat Tucson will attempt to assure a safe work environment and to comply with federal, state and local safety regulations. In turn, you are expected to obey safety rules and to exercise caution in all work activities. If you are a construction site and/or a HabiStore volunteer, we suggest that you participate in an online safety course offered by Habitat's insurance carrier, Lockton Insurance.



Immediately report any unsafe conditions, minor scrapes or cuts, or accidents to the site supervisors. If you witness someone participating in unsafe conditions, please correct these conditions as promptly as possible. Possession of dangerous or unauthorized materials, such as explosives or firearms in the workplace are prohibited and may result in termination. Harassment of any kind including sexual harassment is prohibited and grounds for termination.

Comprehensive construction site safety guidelines are described in the "Safety Handbook for Construction Crew Volunteers". These safety guidelines are available at each construction site, the HabiStore and the administration office.

Drug and Alcohol Use

As a volunteer, you will not be under the influence or use illicit drug/alcohol while at the Habitat workplace or while working as a Habitat family partner. Be sure to check prescription medication labels for warnings that may limit your ability to operate machinery, drive, etc. Please take care of your health before returning to Habitat duty.



Additionally, the unlawful manufacture, possession, distribution, transfer, purchase, or sale of alcoholic beverages or illegal drugs while on Habitat Tucson's property, while attending to business-related activities or while on duty is strictly prohibited.
